## Sub: Implementation of Revenue Maximization Policy by HMRDC

- I. It is hereby notified for the information of public that HMRDC is implementing the following Revenue Maximization Policy by offering slab-wise discount for the movement of coal commodity through rail via HMRDC section (Mangalore Hassan) to all Coal customers.
- II. Considering the decline in the traffic moved over the last three years, it is felt necessary to introduce policy for revenue maximization to all customers on incremental traffic of Coal to induce them to move traffic in HMRDC section.
  The policy is as follows:

## III. Applicability of the Proposal:

- 1) The Policy will be limited to Coal traffic only. No discount is proposed on other commodities since the existing rate per tonne is low.

- 3) The policy will be applicable only when the customer is not utilizing the Railway concession scheme or any other scheme by Government.
